## **Dogs Rule Daycare & Boarding Policies**

Our purpose is to provide a safe, fun and exciting social environment for dogs. The dogs play together supervised by one of our daycare staff. For a break in the excitement there is a scheduled naptime midday. To ensure our guests are comfortable with their playmates we have two separate daycare areas designated for smaller dogs and larger dogs. Please remember your pet will be spending time with other guests and the safety and health of all animals is our main concern. Therefore we require all guests to obey with the following rules and regulations:

1. AGE: All dogs must be at least 16 weeks of age or older.
2. SEX: All dogs must be spayed or neutered.
3. VACCINES: All dogs must have up to date vaccines given by a veterinarian. Clients must submit proof of DHPP, Bordatella, and Rabies.
4. FLEA TREATMENT: We are a flea free environment. If your dog is not currently protected with a flea treatment and fleas are found on your dog during his/her stay, Frontline will be applied. Additional charges will be added to the client's account.
5. HEALTH: All dogs must be in good health. Clients will certify their dog(s) are in good health and have not been ill with a contagious condition in the last 30 days. For dogs that have been ill in the last 30 days clients must provide documentation of health from their veterinarian to be admitted or re-admitted to daycare.
6. BEHAVIOR: All dogs must be non-aggressive with humans, other dogs, around toys or food. Clients will certify that their dog(s) have not harmed, shown aggression, or shown threatening behavior towards any person or other dog.
7. PERSONAL ITEMS: If you would like to bring personal items for use during naptime you may. We can feed your pet if needed, this will be done separately from the other dogs. We are not responsible for loss or damage to personal items.
8. AGREEMENT: All dogs must have a complete, up to date and approved agreement on file.
9. DAYS AND HOURS: Daycare is open Monday-Friday from 6 a.m. to 7 p.m. Boarding drop off is Monday-Sunday from 6 a.m. to 7 p.m., unless prior arrangements have been made. Boarding pick up is Monday-Sunday 5 p.m. to 7 p.m. If dogs are not picked up by 7 p.m. they will be boarded. Additional fees for boarding will be added to the client's account.
10. RESERVATIONS: Clients are recommended to make reservations to ensure there is space available for their dog(s) in daycare.

Dogs Rule cannot guarantee the health of any pet, but pledges to give appropriate care to all guests. By signing this form I hold Dogs Rule harmless for conditions that are unavoidable in pet daycare environments such as, but not limited to: minor cuts and scratches, kennel cough, upper respiratory infection, diarrhea, etc.

I authorize \$ [redacted] for emergency treatment of my pet(s) in the case that I or my emergency contacts are not available. If I cannot be contacted, I authorize my emergency contacts to make necessary medical and financial decisions on my behalf regarding my pet(s). Should the pet(s) identified on this agreement require care, my emergency contacts are authorized to pick-up and transport my pet(s) to a veterinary care clinic. If my emergency contacts are unavailable, I authorize the Dogs Rule staff to transport my pet(s) to my family veterinarian or nearest animal emergency clinic. If transportation is provided by Dogs Rule the fee will be charged to my account. I agree to pay all related expenses associated with the treatment of my pet(s) to the appropriate veterinary clinic.

Clients are accountable for their dog(s) behavior while attending daycare. By signing this form I take full responsibility for any damage caused by my dog(s) while attending Dogs Rule Daycare & Boarding.
